Talisman Sinopec Energy UK Limited (acting as Clyde Operator and Clyde Owner) and First Oil Expro Limited as Clyde Owner and Maersk Oil (acting as Affleck Operator and Affleck Owner) and Talisman Sinopec North Sea Limited as Affleck Owner. 2. The Affleck Owners wish the Clyde Owners to make modifications to enable Affleck gas to be received into (and transported through) the Clyde facilities 3. The Affleck Owners wish to construct and install pipeline facilities and tie-in same to the Clyde facilities 4. The design, construction, installation and pre-commissioning of the new Affleck and Clyde facilities shall be performed in accordance with the terms of the agreement
